MEMORUM OF UNDERSTANDING

This Memorandum of understanding (MOU/MOA) is executed at Kolkata on the 2 6th Day of March 2019 between Netaji nagar college for women (to be referred as licenser) at , 170,436 Netaji Subhash Chandra Bose Road, Netajinagar, Kolkata 700092, through the Principal of the College Dr. Tapan Kumar Ghosh who is Duly authorized & component to execute this MOU/MOA on behalf of the college.

AND

ESSR INFOSYS (A Division of ESSR Group) having its registered office at 71, Charu Chandra Place (East), Kolkata – 700033, through its Partner Sm Urmi Adhikary who is duly authorized & component to execute this MOU/MOA on behalf of ESSR INFOSYS (to be referred as licenser)





Whereas the licensee is engaged in the field of imparting education in the field of computers, management, teacher training, soft skill and has acquired and developed specialized models, unique techniques, practices, knowledge, Expertise, Skills, Distinctive logo, Layouts, Education facilities And methods both practical & theoretical for individual as well as groups in many areas of applications.

Now the Licenser and the Licenser have mutually agreed as follows.

- That the licenser hereby appoints ESSR INDFOSYS registered office at 17, Charu Chandra Place (EAST) KOLKATA-700033. The authorization is for the purpose of imparting trainings and conducts such courses as are duly authorized in writings by the Licensee from time to time.
- That this licensee at its own cost will maintain all the infrastructural facilities relating to the training (More precisely cost of Course Materials or stationary (if any, salary of faculties). Licensee will not be paying any corporate tax, rent or electric charge to licensor.
- 3. That the licensee will be allowed to display the signboard, notice etc. into the college premise.
- That the licenser will be allowed to publish the name of the licenser in any advertisement via media as their authorized Training Centre.
- 5. That the Licensee shall recruit/ appoint/ the necessary teaching and non teaching staff to run the unit at the centre of the licensee, as per the standard lay down by the licensee from time to time, to maintain the best education standard of the centre.
- 6. That the salary/ remuneration/ alliance of specified subject's staff will be bared by the licensee.
- That the licensee will use the room allotted to it for the purpose of setting of the said facility and use the electricity during classes.
- 8. The <u>COURSE offered</u> for the Training programs are as follows: Teacher's Training Programs; Basic; Multimedia; Programming; Accounting with GST; Hardware & Networking; Computer Application & Communicative English, Management.
- That the Licenser shall not be empowered to make any change in the fee structure without prior permission of the licensee.
- 10. That the sharing of fees of these students belonging to the licenser will be as follows:
 - a. For Computer Training 30% for the licenser and 70% to the licensee.
 - b. For Communicative English, Management Training- 25% for the licenser 75% to the licensee.
- 11. That the licensee shall deposit the monthly share of the Licenser by cheque in favour of the Licenser.
- 12. That the Licensee will take necessary steps for enrolment of maximum number of students.
- 13. That the course will be of duration from 3 month to 3 years and the licensee will provide the course materials and faculties for students as and when required.
- 14. That on successful completion of the course every student shall be provided with a certificate under the seal and authority of both Licensee and Licenser.
- 15. That the responsibility relating to counseling vis-à-vis selection of right courses for particular will rest with the licensee.
- 16. That the students of licenser who had persuade any course with the licensee either as part of their academic or otherwise be allowed to pursue their course, by paying the same fee as was being paid earlier.



- 17. That the licenser as well as the licenser, who had persuade any course with the licensee either as part of their academic or otherwise be allowed to pursue their courses, by paying the same fee as was being paid earlier.
- 18. That the licenser as well as the licensee will as the licensee will have the right to terminate the agreement, if any party is found violating the conditions of this agreement, by giving one month's notice and both the parties will remain bound to abide by it.
- 19. That after the termination of the agreements the licenser shall not be entitled to use of the
- 20. That the students enroll through college reference will be entitled to the course following the scheduled fees as per clause 4 of the agreement.
- 21. That the agreement will remain valid for a period of one year beginning from mutual agreement between a licenser and licensee will continue the subjects to auto renewal of the same every year valid for a period of 3 years.
- 22. That the licenser reserves the right to deny renewal of the same without assigning any reason and the licensee will have to abide by the decision of the licenser in this regards.
- 23. A Committee of few representatives from Licenser and few representatives from licensee will look after the management of the centre and college principal will be the chairman of the committee.
